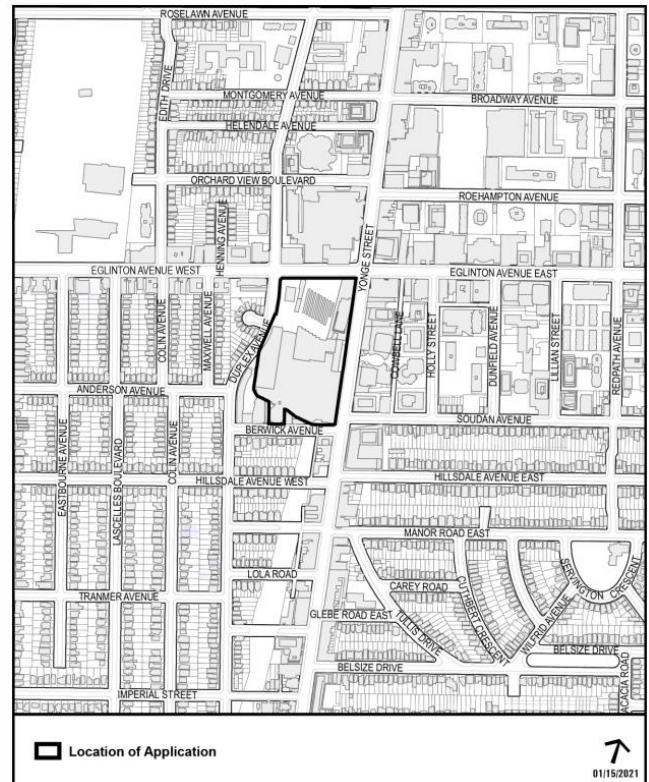
Join us at the Virtual Community Consultation Meeting to learn more about the Midtown Working Group's Vision for the Canada Square site and area north of the site along Yonge Street. The meeting will include presentations and a question and answer portion where local residents and stakeholders can ask questions and provide feedback.

### Proposal

City Council directed City Planning to establish a working group made of up local residents and stakeholders to prepare a vision and priorities that could be considered alongside the Canada Square Zoning By-law Amendment application. City Council also directed City Planning to hold a community consultation meeting to receive feedback on the Midtown Working Group's vision and priorities. A community meeting to discuss the Canada Square Zoning By-law Amendment application will be held soon.

### Background Information

A development application was submitted to the City in December 2020 for a 5-tower development including new TTC infrastructure, a new public road, public park, multiple Privately Owned Publicly-Accessible Open Spaces (POPS), and community space at the Canada Square site located at the southwest corner of Yonge Street and Eglinton Avenue West.

The Midtown Working Group met on May 5, 12, 19, June 2 and 7, 2021. The facilitator submitted a report titled "Imagining a New Town Centre for Midtown Toronto" dated June 2021, outlining six priorities to achieve the Midtown Working Groups vision for Canada Square.
